## Demand Flow Intelligence Limited (In Liquidation) Liquidators' Sixth Report

### 1. Introduction

Demand Flow Intelligence Limited (In Liquidation) ("the Company") was placed into liquidation by order of the High Court at Auckland on the 10th day of July 2015. Kenneth Peter Brown, Chartered Accountant and Paul Raymond Clark, both Accredited Insolvency Specialists of Tauranga were appointed as Joint and Several Liquidators of the company.

Paul Raymond Clark resigned as Liquidator on 7 July 2017 and was replaced by Paul Thomas Manning, Chartered Accountant of Tauranga on the same date.
