## Stages Civil & Electrical Limited (In Liquidation) Liquidators' Eighth Report

19 March 2019

### 1. Introduction

Stages Civil & Electrical Limited (In Liquidation) ("the Company") was placed into liquidation by special resolution of the shareholders on the 16th day of September 2015. Kenneth Peter Brown, Chartered Accountant and Paul Raymond Clark, both Accredited Insolvency Practitioners of Tauranga, were appointed as Joint and Several Liquidators of the company.

Paul Raymond Clark resigned as Liquidator on 7 July 2017 and was replaced by Paul Thomas Manning, Chartered Accountant and Accredited Insolvency Practitioner of Tauranga, on the same date.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.

### 4. Estimated Date of Completion of Liquidation and Notice As To Further Reports


It is not practicable to estimate the date of the completion of the liquidation at this stage. Further reports will be issued six monthly and a final report at the conclusion of the liquidation.
