## TMP Quality Fixing Limited (In Liquidation)

### Liquidators Twenty-second Report

#### 1. Introduction

TMP Quality Fixing Limited (“the company”) was put into Liquidation by order of the High Court at Auckland on 12 March 2008 at 10.29am. Thomas Lee Rodewald and Robert James Neilson, Chartered Accountants of Tauranga, were appointed Joint and Several Liquidators of the above named Company. Thomas Lee Rodewald resigned as Joint Liquidator and has been replaced by Paul Thomas Manning as at the 15 March 2012. Robert James Neilson is deceased as of 25 December 2013.

We set out below our six monthly report on the state of affairs of the above named company as required by section 255 (2)(d) of the Companies Act 1993.


Further reports will be issued six monthly and a final report at the conclusion of the liquidation.
