Samjen Limited (In Liquidation) trading as Bay Dentures ("the Company") was placed into liquidation by special resolution of the shareholders on the 16th day of April 2015, at 9.46am. Paul Raymond Clark, Insolvency Specialist and Kenneth Peter Brown, Chartered Accountant, both of Tauranga were appointed as Joint and Several Liquidators of the company.

Paul Raymond Clark resigned as Liquidator on 7 July 2017 and was replaced by Paul Thomas Manning, Chartered Accountant of Tauranga on the same date.
